- 1. The Plaintiff, Meagan Whitney Fender, is a citizen and resident of the County of Beaufort, South Carolina.
- 2. Upon information and belief, the Defendants, Henry Dunbar and Katherine Schneider Dunbar, are a citizens and residents of Charleston County, South Carolina.
- 3. On or about December 14, 2019 at our around 5:50 p.m. the Plaintiff was driving her 2017 Hyundai automobile and was stopped on Savannah Highway in Charleston County, South Carolina and when suddenly and without warning the Defendant, Henry Dunbar, driving a 2012 Infiniti automobile, which was owned by the Defendant Katherine Schneider Dunbar, ran into the rear of Plaintiff's vehicle.
- 4. The aforesaid wreck was a direct and proximate result of the careless, negligent, reckless, or willful acts and conduct of the Defendants, in one or more of the following particulars:

- b. In entrusting her vehicle to the Defendant Henry Dunbar, when she knew or should have known that said Defendant was not capable of safely operating said automobile.
- 5.
